The City Council of the City of Piedmont met in regular session at the time and on the date above. Present were Mayor Baker, Council Members Richard Williams, Jubal Feazell, Greg South, David Ivey, and Terry Kiser.

Following the invocation by Greg South and the pledge of allegiance given by Mayor Baker, the minutes were presented for consideration. Terry Kiser made the motion that the minutes be approved as presented. David Ivey seconded the motion and the minutes were approved.

The bills totaling \$428,922.49 were then presented for consideration for payment. Richard Williams made the motion that the bills be approved as presented. Jubal Feazell seconded the motion and the bills were approved for payment.

The next several items involved abatement resolutions. Richard Williams made the motion to approve Resolution 2024-06. Terry Kiser seconded the motion and the motion carried. Richard Williams made the motion to approve Resolution 2024-07. David Ivey seconded the motion and the motion carried.

The Mayor read the Proclamation for the Nursing Home.

The next item on the agenda was the voting delegate for the AMEA. Terry Kiser made the motion to reappoint Greg South as the voting delegate. Richard Williams seconded the motion and the motion carried.

The Mayor was given a letter of resignation from Brent Morrison, who serves on the Commercial Development Board. He asked the Council to consider a replacement in the near future.

Tim Frost asked the Council to replace a full time employee that will be leaving next week. Jubal Feazell made the motion for Tim to replace that employee. Richard Williams seconded the motion and the motion carried.

After the Police and Fire Reports there were no visitor comments.

In Council reports, John Lawrence was absent.

Richard Williams asked about the progress on the roofs for the electrical and street department. He congratulated Michael Devoe on his award. In closing, he also thanked Tessa for the work she does at the Library.
