The City Council of the City of Piedmont met in regular session at the time and on the date above. Present were Mayor Baker, Council Members John Lawrence, Richard Williams, Jubal Feazell, Caleb Pope, Greg South, David Ivey, and Terry Kiser.

The next item on the agenda was Resolution 2024-11. Greg South made the motion to approve Resolution 2024-11. Terry Kiser seconded the motion and the motion carried.

Resolution 2024-12 was the next item. Richard Williams made the motion to approve Resolution 2024-12. David Ivey seconded the motion and the motion carried.

Resolution 2024-13 was the next item. Richard Williams made the motion to approve Resolution 2024-13. Terry Kiser seconded the motion and the motion carried.

Resolution 2024-14 was the next item. Greg South made the motion to approve Resolution 2024-14. Terry Kiser seconded the motion and the motion carried.

The next item on the agenda was the Calhoun/Cleburne Drug & Violent Crime Task Force request for \$5,000.00 for the FY 2024. Richard Williams made the motion to approve the request of \$5,000.00 for the Drug & Violent Crime Task Force. Caleb Pope seconded the motion and the motion carried.
